ACKNOWLEDGEMENT

Prior to participating in County Probation and Parole Officers' Firearm Education and Training Commission SIMUNITION® Training, I acknowledge understanding the following:

1. County Probation and Parole Officers' Firearm Education and Training Commission SIMUNITION® Training is designed to provide participants with quality, reality-based training using force-on-force exercises against another person or persons who can shoot back.
2. County Probation and Parole Officers' Firearm Education and Training Commission SIMUNITION® Training will require that participants fire SIMUNITION®'S FX® Marking Cartridges at one another.
3. The use of SIMUNITION®'S FX® Marking Cartridges demands the same firearm handling precautions as duty ammunition and the reloading of magazines is strictly prohibited.
4. The SIMUNITION®'S FX® Marking Cartridges leave a detergent-based, water-soluble, color marking compound residue upon or after impact. Clothing may be stained or damaged.
5. Participation in County Probation and Parole Officers' Firearm Education and Training Commission SIMUNITION® Training requires that I wear, at all times, appropriate protective equipment which includes at least the protective facemask, throat collar, groin protector and gloves and that non-lethal injuries, including but not necessarily limited to, bruises, welts or scrapes may occur during this training.
6. Only firearms that have been converted to safely fire the SIMUNITION®'S FX® Marking Cartridges will be used during County Probation and Parole Officers' Firearm Education and Training Commission SIMUNITION® Training. The use of any other firearm during this training is strictly prohibited.
7. For safety reasons, it is recommended that shooters maintain a minimum three (3) foot safe distance (standoff) between themselves and their targets when firing SIMUNITION®'S FX® Marking Cartridges at personnel.
